

USE OF SCHOOL BOARD PROPERTY BY LICENSED CHILD CARE PROVIDERS

Background

The Government of British Columbia through Ministerial Order M326, the Child Care Order, and the District through [Policy 22](#) promote the use of available District facilities and space either by the board or third party licensed child care providers between the hours of 7 a.m. and 6 p.m., during business days.

Procedures

1. Principals shall support such child care programs in accordance with [Policy 22](#) including support for information gathering work of the sub-committees prior to a determination as to whether such a program is to be operated either by the Board or a licensee on school district property.
2. As noted in [Policy 22](#), the use of District property by licensed child care providers must not disrupt or otherwise interfere with the provision of educational activities, including early learning programs and extracurricular school activities.
