3. BUSINESS ARISING FROM PREVIOUS MEETING

3.1 Draft Policy 3.11 Independent Directed Studies

Feedback from partner groups was reviewed.

Discussion included:

- an IDS project template from MBSS was provided it will be reworded to match the policy and will become a regulation
- an IDS can be done in Grades 10-12 (anything connected to the Grad Program)
- a DL student can apply for an IDS with a slightly different time line than 'one month in to the semester' as indicated on the template form
- with the revised curriculum, this option might become more common how do we
 promote this option to students? What does it look like in a classroom? What
 does it look like for teachers? There is definitely some work to do and
 conversations to have to ensure it doesn't become overwhelming for staff possibly establishing a block where all students completing an IDS are scheduled
 in that block; it could fall under work experience and/or career prep.
- although the policy is new as a result of the MBSS audit, the concept is not new teachers/counsellors are already doing it
- change the title on the template from Individual Education Plan to Individual Project (or Program) Plan
- Trustee request to see a list of these projects from time to time
- send any feedback on the template to Diane prior to May Board meeting.

Recommendation A

3.2 Revised Policy 5.4 Student Eligibility for Bus Service

Updates/discussion included:

- Bill Graham, Transportation Supervisor, has been asked to source out a transportation audit/review (not route optimization, which is already done annually)
- there are differences in transportation in each community and specific reasons for the differences
- · we need to work in conjunction with city transit
- there is \$20,000 set aside from the transportation budget for a transportation audit
- looking at getting some extra help to pull a strategic plan together
- Mr. Norum called the Ministry they want to see a strategic plan, which outlines what we are asking for
- possibly look at communities individually as the needs vary
- our policy should be defendable in court should something go wrong possibly a more general policy and then sections pertaining to individual communities
- important to be consistent across the district when dealing with student safety
- could look at the time it takes to walk a certain distance instead of just distance (can make a big difference for primary students)

- could we work with the municipalities in each community to see if some of their city transit busses could be rescheduled to better meet the needs of our students (i.e. what is done in Nelson)?
- Trustee Bellina has been contacted by parents with issues involving wild life and traffic at certain locations around Sparwood
- COTR students ride the city transit for free (sponsored by COTR and BC Hydro) could we do the same? (Part of the student fees their students pay includes this
 service.)

The revised policy will be tabled until the May meeting.
