The Board will pay transportation assistance to the parents/guardians of students who qualify for transportation and for whom it is not cost effective, practical, or possible to provide bus service.

There are inherent limitations transporting students, in accordance with the School Act, bus transportation for students is provided at the discretion of the Board. Consistency and transparency are critical to this policy. The routes will be reviewed and adjusted as needed through the Administrative Procedure Manual. It is recognized that bus transportation routes will not suit the requests of all parents/guardians.

Transportation services will be available for those students enrolled in the district and will be defined by community in the Administrative Procedure Handbook.

The Chair, on behalf of the Board, sends his condolences to Trustee Whalen on the tragic passing of her father just one month after losing her mother. We also send our condolences to her husband Sean and their family.

The Chair expressed his gratitude to Secretary Treasurer Rice and Superintendent Yardley for scheduling COVID-19 vaccines for SD5 Cranbrook staff over the weekend.

The Chair expressed gratitude to all mothers on Mother's Day for their unending love.

Chair Lento introduced Heather Halliday. Heather began by indicating she is representing 200+ parents of school district 5 and concerned citizens. She proceeded with her presentation to the Board explaining the concerns that have been voiced on discrimination and the rights of children while attending school. A few of the referenced documentations in the presentation were the health risks of mask wearing, the BC Human Rights Code, a seven-page document with notice to school faculty, and court cases on discrimination and human rights.

Heather expressed her appreciation for the Boards time and expressed she will be forwarding her presentation package. She recommended the Board take the time to read the referenced documents to encourage facts over fear. She also asked that her question be answered. Is it mandatory for all school faculty to read the Stage 2 Return to School Guidelines and/or the Provincial Covid 19 Health and Safety Guidelines for K-12 Settings?

Chair Lento thanked Heather for her presentation and because of the serious nature of her presentation he granted her extra delegation time. He gave the trustees a chance to ask questions.

1. COMMENCEMENT OF MEETING

1.1 Call to Order

I want to acknowledge that we have gathered here in the Homelands of the Ktunaxa people.

The Advocacy/Education Committee Meeting of May 31, 2021 was called to order at 9:33 a.m. by Co-Chair Bellina.

Chairperson Lento acknowledged the horrific news about the 215 children in the Kamloops Residential School.

"A few comments regarding the agonizing and tragic circumstances that have been brought to our attention of not only the Residential School in Kamloops but also the anticipated devastation of others throughout Canada.

While we have lowered our flags, our schools, under the leadership of our Superintendent, our Directors of Student Learning and our Aboriginal Education Support Workers, are honoring those in different ways throughout our community schools who suffered trauma, harm and ultimately never returned home. The agonizing circumstances for the families and the community of the Kamloops Residential School is beyond comprehension for me. We are concerned about the trauma and anxiety being experienced by our local Ktunaxa Nation and the impact of our local Residential School. I would request that our Superintendent arrange a meeting with Chief Pierre as soon as possible to offer our help in the form of compassion, understanding, support, resources and hope.

Please join me as we begin our day about the education and welfare of our students by taking a moment of silence to reflect on the past trauma and harm and share in the grief of the victims' families of the Kamloops Residential School."

3.1 Capstone Presentation - Chantel Hennessy and Karen Kettenacker

Chantel Hennessy, a Grade 12 student at MBSS, presented her Capstone. She shared her personal stories and her struggles with various disorders. She described each disorder and how they have affected her life.

4. REPORTS

4.1 DSAC Report

Trustee Bellina gave a recap of the DSAC meeting on May 15. Amy Reid spoke to the students about mental health supports in COVID. Director Tichauer continued the work already started on the career development priority for the Framework for Enhancing Student Learning and asked the student what topics they would like to see on future agendas. The next meeting is June 3, 2021.

4.2 DPAC Report

Trustee Turner reported it was a busy meeting in May. Highlights included:

- secondary school PACs discussed grad plans as the Ministry did release guidelines which gave them definitive things to look at when planning special events for students
- traffic around MBSS has slowed down with the school leadership team reminding everyone of the traffic issues
- Director Casault presented EDI information and parents were very grateful
- BCCPAC parent conference was held May 28/29
- LMS hoping to get flashing lights on 2nd Street South
- IDES heard about the bussing survey and congestion problems part of transportation discussion
- questions about policies for students riding the bus; the number of kilometers and whether that would be discussed and looked at; they were assured that it is all part of the discussion following survey results from different communities
- SOGI 123 concerns at SSS; more needs to be done to inform parents on SOGI and to make sure they have access to websites and information from BCCPAC to help them have discussions with their own children

 Director Tichauer did a great job talking to DPAC and addressing their concerns; he is meeting with DPAC executive before next meeting in June to set up a parent information session

4.3 Framework for Enhancing Student Learning (FESL) - update by Silke Yardley

Superintendent Yardley indicated good progress was being made with the Framework document. The DSAC students are meeting this week and their suggestions will be put into the document as strategies. The students have been very engaged.

A survey was sent out last Friday to all school staffs asking about what they would like to see for professional learning from the district. So far, 85 responses have been received. Group meetings are being set up with principals, unions, district staff, and teachers starting June 14 to look at the survey results and to come up with a good plan for offering professional learning for our staff based on the needs of the Framework. The ultimate goal is to finish action items in the Framework, to have a plan for next year and share professional learning opportunities with the Principals/Vice-Principals in August. The final Framework document will be complete at the end of June and then shared with Trustees.

4.4 Child Care - Alan Rice/Diane Casault

Secretary-Treasurer Rice mentioned that renovations were moving forward at the Fernie Learning Center and the Center will be ready to go in September with additional day care and before and after school care. This is Phase 1 of many phases to come. Thanks to the maintenance staff who have been very helpful and organized in getting things moving forward.

- really important to have this conversation and you see what can happen if no one speaks up
- is this Protocol is across BC and is the reporting going to help the BC government determine what supports, education are needed across the province?
- Director Tichauer explained that this is a locally created document which may get provincial funding
- Resilience BC is creating lots of resources
- Humanity Network also linking to provincial resources; helps with what is not appropriate
- many "spokes" to Resilience BC; we are lucky to be on the leading edge in Cranbrook; we represent much larger region; other communities will piggyback on this

- Removal of defined transportation assistance dollar amount
- Clarification of transportation services for courtesy riders and priority (approval and protocols for courtesy riders will be provided in the Administrative Procedures Handbook)

Secretary Treasurer Rice also advised the Committee that the administrative procedures for this policy will be reviewed later in the month of June.

Chairperson Lento stated that the Transportation Policy was flexible and long overdue. He also stated that the last sentence under the section, Ridership Eligibility, should be moved to the beginning of the section., "The Board will pay transportation assistance to

the parents/guardians of students who qualify for transportation and for whom it is not cost effective, practical, or possible to provide bus service."

Trustee Bellina commented that the transportation policy was clear and concise and thanked Trustee Damstrom and Secretary Treasurer Rice for their work on the document.

Trustee Kitt questioned if the new Transportation Policy could be incorporated into the newly revised documents and then be approved at the time when the Board Policy Handbook and Administrative Procedures Manual are approved.

Chair Lento confirmed that Dr. Leroy Sloan would like the Board's consensus and endorsement on the Student Bus Service policy before adding the revision to the Board Policy Handbook.

Consensus was reached and the amended document with change will become part of the Board Policy Handbook.

Ridership Eligibility

The Board will pay transportation assistance to the parents/guardians of students who qualify for transportation and for whom it is not cost effective, practical, or possible to provide bus service.

There are inherent limitations transporting students, in accordance with the School Act, bus transportation for students is provided at the discretion of the Board. Consistency and transparency are critical to this policy. The routes will be reviewed and adjusted as needed through the Administrative Procedure Manual. It is recognized that bus transportation routes will not suit the requests of all parents/guardians.

Transportation services will be available for those students enrolled in the district and will be defined by community in the Administrative Procedure Handbook.

2. BUSINESS ARISING FROM PREVIOUS MINUTES

2.1 Inclusive Education Working Group update (Diane/Darcy)

Mr. Verbeurgt shared the roadmap that the Inclusive Education Working Group has been working on for the past year and a half. This same group was largely maintained this year from last and have come up with this process to work through suggestions and changes. The roadmap has been broken down into calendar years. We will re-evaluate the process each November and develop budget processes for that calendar year. It has been timed to hit budget cycle.

The Partner's handbook from the Ministry of Education (MOE) is now in review with a late September launch anticipated. This will help to frame the work we do over the next couple of years.

There is a commitment from Mr. Verbeurgt to reduce the levels of paperwork required in the support roles. We will look at key indicators of support rather than keeping a lot of notes. There will be guidelines on the minimum of paperwork required to meet proper documentation. There will be a clean up of forms that are now obsolete.

November will bring back the working group to review and see if we have met the pieces that we wanted to meet as well as identify pieces that we may have missed. The mental and social emotional aspect will be paramount in September.

We know that kids do better when there is a solid understanding and support of their social being is in place. The need to do some of those soft skills are often the hard skills of being human.

As we work on other plans in the district, we will look at where we are in the FESL, human and social development, aboriginal education as well as opportunities to continue into post secondary education. Literacy and numeracy are two areas we need to complete to a significant level before they leave school. This will be a year of focus so we can direct some of the funding in that direction. 2023 will be the big year where we focus on literacy and numeracy. We will address the pieces that we need to, and our literacy and numeracy district wide assessments will be entrenched. In service and professional development sessions will be many as we focus on the different areas. We will then have a better direction and more cohesive plan.

2.2 SELC update (Darcy)

SELC program will be finishing at PES on June 4th. The SELC teacher will go to TMRES for their pro-d as this will be their first school in fall. Focus will be on the Grade 2&3 French Immersion classrooms. Some materials will be converted into the French language to support this school. The YCW will tidy up reports for each school. We will do a summary for the district staff as well. The YCW and EA will be returning to SES to wrap up their work there and bring them to a successful June finish.

2.3 Update of existing IEPs

We have approx. 800 IEPs in the district. This time of year, expectations of work is that we have transition meetings between buildings. We have several kids that in a normal year would have been taking a class at another school in late June or

early September. Because of COVID, different supports are in place. Student Service's Teacher's (SST) will start looking at IEPs on May 15th for the end of the school year.

We are moving towards reporting progress specifically on a report card in a class found in MYED. It would be written by the SST and classroom teacher. Principals have been asked to check on their IEPs where there is a need for them to be revisited. In many ways, we are hampered by COVD as there are more restrictions. We look at transitions as important aspect of what we do.

2.4 Update on Psychology Education assessment

There is a gigantic need for kids needing assessment in January. We have completed 44 cognitive assessments in Cranbrook and a number in the Elk Valley. 15 of those are in the completion process and part of a work list that is approx. 89 kids long. At this time of year, we have a significant number more than what we normally have. There will be 30 starting in September prioritizing assessments based on need. The majority in spring were for kids heading off to post secondary education. We are in great shape in the Elk Valley and ok shape in Cranbrook.

Regarding implications on funding, kids assessed are not necessarily funded. Approx. 3 kids a year assessed with an intellectual disability that gets funding. Assessments bring in about \$60,000 per year and provide information on how we can better serve kids. The funding helps us access tools for these students.

As far as following these students after they leave, the more complex kids are followed. Student Services often know where they go in terms of those that need a lot of care, wheelchairs, etc. Families develop a strong connection and often keep Student Services informed of where they are going and how they are doing. Sometimes Secondary level teachers will reach out to update former teachers on a student. They are making changes in MYED system to track how many of our kids transition out of province.

4.1 Stage 2 Restart Protocol Update - Secretary Treasurer

Secretary Treasurer Rice expressed that the Ministry of Education (MoE) has indicated there will be no changes to the current protocols before the end of the current school year. In the next 2-3 weeks, he expects to receive some guidance from the MoE as to the protocols for September. The MoE is indicating that the districts should plan for stage "1.5" for September.

Co-chair Johns asked about the graduation protocols. The district received a one page memo from the MoE on graduation protocols. Secretary Treasurer Rice replied that he and Superintendent Yardley have worked with the schools on their graduation plans to ensure they are within the protocols.

The Board inquired if the MoE will provide extra funding for day-time custodians in September. Secretary Treasurer Rice replied that this question has come up in budget meetings and the MoE asked that this be managed from within the district budgets. We will look at our surplus at the end of the year for any appropriations for this purpose.

4.2 Stage 2 Restart Protocol Update – Superintendent

Superintendent Yardley mentioned that schools have had pressure to lighten the protocols in place. The Ministry of Education is advising the school districts to maintain the same protocols. The secondary schools have submitted their individual plans for graduation, and they all align with the stage 2 protocols.

We will have to live with COVID-19 in our schools like we have other viruses.

We have had some pressure from the sports enthusiasts. The school districts will stay in stage 2 until September and then see where we are at.

Superintendent Yardley advised that she will be meeting with Interior Health tomorrow regarding COVID-19 vaccines for the 12 to 17 student age group. Interior Health has sent a letter home to parents that indicated students have the choice for the vaccine without parental consent. Superintendent Yardley is not comfortable with this statement and will question Interior Health about it.

Co-chair Johns asked that the graduation guidelines be forwarded to the Board along with the graduation plans for each school.

Superintendent Yardley mentioned a glitch in the Interior Health system with the recording of vaccines. She suggested if you do not receive a message from Interior Health for your second shot in the time frame you should, then contact them.

5. NEW BUSINESS

5.1 Budget Update

Secretary Treasurer Rice is working on the budget. He has had budget working sessions with the Board. The operating budget is due the end of June. The capital budget will have staggered dates with the major capital items due July 31st and the minor capital due September 30th.







Again, due to COVID and the physical distancing rules, we used inflatable aliens to administer this training. Valuable skills were learned with a few laughs mixed in!







Earthquake! Hold on, Don't LEGO!

A couple different classes explored the earth at the Design Lab. Students learned about the different layers of the earth and plate tectonics in augmented reality, a technology that displays images in the room when looking through an iPad or other digital camera. Students then had to build an earthquake machine and build a robust structure that could withstand a magnitude 10 LEGO earthquake. They didn't just get to grab their LEGO though. They first had to mine and deliver it by creating a robotic delivery system using the new Design Lab Ozobots.

Once their prototype building had passed the test, students took their designs to the next level of scale and built bigger buildings for the larger earthquake machine. There were a ton of failures at first but with the successful designs, the ideas started spreading and most groups were able to create a robust structure that could withstand the violent shaking.

Game Designers

Students at Parkland Middle School returned to their coding roots and created some amazing scratch games. Most of the students in Mrs. Tichauer's class, have explored coding for a few years now in class and through the Transformative Learning program. They were led through some of the introductory lessons and then shown some additional resources to help them advance their coding. Some creative and fun games spun out of the crowd. Abstract Art and Robotics

Stud<mark>ents in</mark> Ms. Traverse's class briefly learned about a famous abstract pai<mark>nter na</mark>med Jackson Pollock whose one painting sold <mark>for over 140</mark> million dollars in the 1980's. Students then created their <mark>own</mark> abstract art using a Sphero robot.

Virtual Reality

Students in Ms. McMullan's class at RMES and Ms. Woeszczak-Macvic<mark>ar's T</mark>echnology Club from EIDES had the opportunity to try their hand at using virtual reality. Each student experienced an ethereal world where their arms turned green and stretched like plastic, they could teleport within the world. Their experience involved solving puzzles, watering plants, and collecting seeds. Students used problem-solving strategies to move to each new section in the experience.



Dear Ms. Halliday,

We thank you for your presentation to the Board. Input from our parents, guardians and members of the community are integral to the success of our education system.

The K-12 sector is working under the guidance of public health officials and government to ensure educational services and supports are delivered in a manner that prioritizes safety for students, families and staff.

The District is required to have a COVID-19 Safety Plan in place that adheres to the guidance of the BCCDC Public Health Guidance for K-12 School Settings and WorkSafeBC requirements. In addition, government has developed complementary provincial COVID-19 Health and Safety Guidelines for K-12 Settings which all school districts are expected to adhere to. The District's COVID-19 safety protocols are in line with these requirements. Consistent attention to, and application of, preventative measures remain top of mind.

With respect to your question, which you indicated remains unanswered, about whether our employees are required to review the District's health and safety protocols in place for return to school under COVID-19. As per the email sent to you from our Secretary Treasurer (dated April 14, 2021), the following excerpt remains true:

"We have a District Working Committee which contains members from all stakeholder groups (Principal, Administrations, Teachers, CUPE, PAC, Indigenous) which meets regularly to discuss the K-12 protocols from the Ministry of Education (in conjunction with BC CDC and WorksafeBC). From there, we meet with the Principals to share updates and they work with their employees and site Joint Occupational Health and Safety Committees to update the school protocols and also to share the information with our employees. Also, all of our documents are available on our website."

It is the District's expectation that our employees have reviewed and understand the protocols in place for their respective worksites. As the Secretary Treasurer indicated in his email, if you have specific examples which you would like us to follow up on, please contact us.

With respect to your concerns of discrimination and harassment, the District takes allegations of these nature very seriously, and we ask that you provide details in order for us to investigate the incidence(s).

Lastly, we have included a copy of the mask exemption, which was recently provided to the District. The District's position is that students, employees or visitors who cannot tolerate wearing a mask for health or behavioural reasons are not required to do so. Further, we will work with those individuals (and their parents/caregivers, if applicable) to explore other measures to ensure their safety and the safety of others.

School District 5 (Southeast Kootenay) is following up on a previous request asking for a speed limit change to a portion of Hwy 3 east of Jaffray.

Due to the number of close calls and near misses with children and parents in the area, the school district strongly supports the reduction of the speed limit to 70 km to continue for an additional 2.5 km east of Jaffray and increase to the 100 km after the Sand Creek Bridge.

The school district has again analyzed our bus route and we have five bus stops along this stretch of hwy. Our drivers do their best to monitor the traffic for their stops, but there is mainly a disregard of bus traffic rules resulting in many situations of near misses. This stretch of highway has become an immense safety challenge.

The safety of our students and bus drivers is paramount and the stretch of Hwy 3 in question to lower the speed limit is supported by the Board of Education of School District 5 (Southeast Kootenay).

Thank you for your letter of May 13, 2021, addressed to the Honourable Selina Robinson, Minister of Finance and me, regarding funding in Special Education in Southeast Kootenay Schools District. I commend you, the Board, the administration and staff of the District for your commitment to providing quality education to your students, particularly those with disabilities and diverse abilities.

I understand your concerns about these students and their additional needs. Funding for students designated in categories A to H is provided as a supplement within the operating funding that is not targeted. Funding for students in categories K, Q, R and P was incorporated into the basic per student FTE allocation when the current funding model was introduced in 2001.

Provincially, government has increased overall funding for students with special needs by 43 percent (\$200 million) since the 2016/17 school year, and for the 2021/22 school year an additional \$37.3 million has been allocated for students with special needs, a 6 percent increase. This is part of an additional \$260 million in operating grants to school districts that has been announced for 2021/22, increasing operating grants to \$5.756 billion.

I will consider the points you have raised as we contemplate the Phase 2 of the funding model review recommendations.
