To whom it may concern

It has been brought to our attention that a program currently being used in our Kindergarten classroom is being taken away. Changemakers is a program offered by the District SEL Resource teacher. Our kindergarten teacher has been informed that our school will no longer be offered support by the District SEL Resource teacher and since the program was purchased with allocated SEL funds she is no longer allowed to use it.

We would like to understand why our school can not have access to a program that is funded by the district, a program we are currently using. Or at the very least why our teacher can not finish using the program. But we would also like to know why Social Emotional Learning is no longer supported at our school.

This program is very valuable to our students and our teacher. It is a social-emotional learning teacher resource that provides a lesson-based approach to Social Emotional Learning (SEL). It teaches the kids about their brains, self-regulation, awareness of self, understanding others, kindness, compassion, empathy, hope....etc. Social Emotional Learning has always been integral in our Kindergarten class, but coming out of covid, it is even more important for our learners to gain these self-regulation skills. All the lessons include an 'Equity Lens' and a 'Trauma Lens,' for the teacher's insight, which is huge when working within a trauma-informed practice. The program includes a manual, all the associated picture books, and everything the teacher needs to run the program. SEL is fundamental to learning and without it, all the other subjects, math, literacy, science etc can't occur.

This concern has been brought to PAC with the hopes that PAC might be able to fund the \$850 program so that our teacher can continue using it. While we value this program and want it to continue we are confused as to why a Parent committee has to be asked to fund a program our district already owns, a program our district sees the value in.

We look forward to your response and we hope an arrangement can be made.
